

**NBRA RIDER RELEASE AND COVENANT NOT TO SUE**

Agreement: As consideration for being allowed to participate and/or compete in the National Bull Riding Association Event, the undersigned (PLEASE PRINT) agrees to the following:

1. Acknowledgment of risk: The undersigned acknowledges that bull riding events are dangerous activities and that participation in bull riding, as a contestant, an employee or volunteer, exposes the participant to a substantial and serious risk of property damage, personal injury or death. The undersigned expressly acknowledges that his participation in these events will involve such hazards.
2. Release of sponsors and promoters: The undersigned, being aware that participation in the bull riding event will expose him to a substantial and serious risk of property damage and/or personal injury or death, hereby releases all National Bull Riding Association, LLC. all sponsors & promoter, and their respective officers, directors, employees, agents, affiliates or representatives (hereinafter collectively referred to as "Releasees") from liability for any and all property damage, personal injuries or other claims arising in any way from the undersigned's participation in the bull riding event, including those that are known and unknown. This release specifically includes any liability of the Releasees for their own negligence or breach of warranty.
3. Covenant not to sue and indemnification agreement: The undersigned agrees he shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, claims and demands hereby waived, released or discharged by the undersigned. The undersigned agrees to indemnify and hold the Releasees harmless from any and all liability, expense, loss or damage, specifically including any liability, expense, loss or damage arising from the Releasee's own negligence or breach of warranty, and to provide a defense or to reimburse any cost that the Releasees incur if the Releasees provides their own defense (including, but not limited to, reasonable attorneys fees and costs) in connection with any demand, claim or legal action, threatened or actual, including any third-party claim asserted against the Releasees that arises wholly or in part out of the undersigned's participation in these events.
4. Assurances: The undersigned has full power, authority, capacity and right without limitation to execute, deliver and perform this release.
5. Binding effect: This release shall be binding upon the undersigned and the undersigned's spouse, legal representatives, heirs, successors, assigns or transferees.
